# ADMIRALTY SOLICITORS GROUP (ASG) STANDARD WORDINGS

### INTRODUCTION

- 1. Cases of salvage, collision, cargo claims against ship, and other Admiralty incidents usually give rise to demands for security and to a threat of arrest. The interests of clients are best served in such cases by the parties and their respective legal advisers being able to utilise standard security and jurisdiction wordings. The standard wordings in the documents listed below have been agreed by members of the ASG. They have stood the test of time and will be familiar to a large number of clients and guarantors worldwide and their use either in their unamended form, or as a framework for adaptation, can ensure that security and jurisdiction issues are resolved quickly and economically.
- 2. The wordings are kept under review to take account of legal and other developments. The date of the latest version of the document is shown in the top left hand corner. The documents are available in either PDF (Adobe Acrobat) or DOC(MS Word) format.
